A-Grade - All wood-based packaging waste such as scrap pallets, cable drums, and wooden boxes constructed from solid timber products. Processed off-cuts from the manufacture of untreated products.

B-Grade - As per 'A-Grade' plus industrial waste wood, demolition timber, construction materials and domestic wooden furniture. Can include painted window frames and doors with glass removed.
